There is no limitation on the number of team relays a team can enter, but each swimmer may only swim in one team relay.

MIXED AGE-GROUP RELAY	Mixed age group relays will be a 4 x 300M with an in-water exchange. The Mixed Age Group Relay will have four swimmers of the same gender. The 1 st leg will be the 11-12 swimmer, the 2 nd leg will be the 13-14 swimmer, the 3 rd leg will be the 15-16 swimmer, and the 4 th leg will be the 17-18 swimmer. The final relay time is determined when the final swimmer crosses the timing mat on shore at the end of the 4 th leg. Two mixed age-group relays per team/event. Each swimmer may only swim in

RACE TIMES

Swimmers will be instructed to start entering the water five minutes before each race start (after you have checked in with race staff on the starting dock), one at a time by race distance and gender. (*Times are estimated*)

- a. Open Water Practice (On course) 7:15 am 7:45 am (Swim at your own risk)
- b. **Event 1&2 1.25K** Males start 8:00 am, Females start 8:10 am (1 LOOP)
- c. **Event 3&4 2.5K** Males start 8:40 am, Females start 8:50 am (2 LOOPS)
- d. Event 5&6 500M (12&under) Males start at 10:15 am, Females start 10:30 am (1 LOOP)
- e. Event 7-10 1.25K Team Pursuit Males Start 11:15, Females Start 11:30
- f. Event 11-16 Relays Males start 12:30, Females Start 1:00
- g. **Event 17&18 Mixed Relays** –Males Start 1:30, Females Start 2:00

CHECK-IN PROCEDURES AND WARM-UP/DOWN				
WAIVER	Every person attending the event MUST sign a waiver prior to coming on site. You will be asked by the parking attendant to read the waiver and sign it when you arrive at the lake prior to parking. Also, every person entering the water MUST be able to show proof that they are an active member of USA Swimming.			
CHECK-IN	Please proceed to the CHECK-IN table to receive your race number and to be body marked after on-site personnel have verified your waiver.			
EVENT TIMING	This event will be a chipped timed event with a camera back-up system. Each athlete will be given a reusable timing chip and an assigned individual number. It will be helpful for the racer to remember their number when exiting the water in case the timer cannot read the marked number.			
MARKING	Every athlete must be body marked with your race number and event.			
WARM-UP PROCEDURE	A warm-up/down area will be open throughout the entirety of the event beginning at 7:30am. We will have a kayak for support in the warmup area. We ask that you warm-up or down and not hang out in the water prior to and after the race. Please note that you cannot enter the warmup area unless you are checked in and body marked. This area is restricted to athletes only.			

SAFETY PROCEDURES			
SAFETY CONDITIONS	If the swimming conditions are not deemed safe (too much bacteria, debris, etc.), the meet will be rescheduled or canceled. Coaches or contact persons will be notified of any delays or cancellations through messaging with meet management, and those contacts will be responsible for relaying this information to their athletes and families.		



	The meet will be swum under all conditions except thunder and lightning. If there is hazardous weather in the area, we will delay the meet 30 minutes per occurrence. We will make every attempt to swim the races. There will be no entry fee refunds.		
SAFETY PROCEDURES	 A. There will be a mandatory Pre-Race Briefing held ten minutes before the start of each event to discuss the course, rules and safety procedures B. You must check in prior to entering the water for any event (warm-up, practice, race) C. There will be a safety jet ski with a lifeguard for any swimmers that decide they cannot proceed. D. If you are in distress – find a kayaker. If you are not near a kayak/jetski – float on your back and signal to safety personnel. E. If you cannot get to a kayaker, get to the closest shoreline. F. We will have an Ambulance onsite to respond to any emergencies or minor incidents.

SAFE SPORT

RECORDING DEVICES	Use of audio or visual recording devices, including a cell phone, is not permitted in the area behind the starting blocks, in changing areas, restrooms, showers or locker rooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned event.			
CHANGING AREAS	Except where venue facilities require otherwise, changing into or out of swimsuits other than locker rooms or changing facilities, or other designated areas, is not appropriate and is strongly discouraged/prohibited. DECK CHANGING IS PROHIBITED.			
DRONES	Operation of a drone, or any other flying apparatus, is prohibited over the venue (beach, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present

ATHLETE ATTITUDE	Athlete conduct will be governed by Part Seven of the USA Swimming Rules and Regulations Handbook. Intentional obstruction, interference or intentional contact with another swimmer may be deemed "Unsporting Impedance" and lead to disqualification. Swimmers shall maintain clearance from other swimmers except at the start, turn, and the finish or where the course or race conditions dictate otherwise. Parents and swimmers should be advised there are a significant number of entrants, open water swimming may be expected to involve inadvertent contact with other swimmers. It is important that swimmers keep a cool head while in the water			
DISABILITY ATHLETES	We welcome registered athletes with cognitive or physical disabilities, and the Referee will make reasonable accommodations to facilitate participation. Please notify the Meet Director or the Meet Referee in advance to allow us to understand the nature of any accommodation being requested.			
RULES	The current USA Swimming open water rules will govern the Meet as outlined in Part Seven of the USA Swimming Rules and Regulations Handbook. USA Swimming Rules 202.3.2 - At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.
